FORMER LAW ENFORCEMENT OFFICER CONCEALED CARRY CERTIFICATION INSTRUCTIONS

Certification Requirements:

- Applicant is a Wisconsin resident.
- Applicant is not prohibited from possessing a firearm under federal or state law.
- Separated in good standing (HR218, 926B (c)) from service as a law enforcement officer for the Brown County Sheriff's Office or an agency the Brown County Sheriff's Office succeeded.
- Aggregate service of at least 10 years or separated due to service-connected disability after completion of probation.
- Applicant provides documentation satisfying s. 175.49 (3)(b)1-3. Wis. Stats.
- Completes firearms qualification required for active law enforcement officers as denoted in s. 175.49(3)(b)5, Wis. Stats.

What the Application Packet Must consist of:

1. A signed and completed application form containing all requested information.
2. Acceptable proof of firearms qualification: a Minimum Standards Handgun Qualification Course certificate issued by a LESB firearm instructor (per s. 175.49).
3. A signature on the application affirming compliance with WI Stats. 175.49(3)(b) 1 - 5.

Type of Firearm Qualified to Carry

The firearms shall be those for which the former officer, with in the last twelve months, has been deemed qualified as a result of meeting the standard qualification for firearms training for active law enforcement officers established by the state.

Certificate Expiration:

All certificates issued are valid for a period of 12 months from the date the Applicant last was qualified with a firearm.

- For separating active employees, the Sheriff's Office utilizes the established state official firearms qualification course annually and provides supplemental training through the course of each year. Officers that separate during the course of the year, as long as they are performing in the Sheriff Office's firearms courses at an acceptable level, shall be considered as qualified for one year from the date of their separation.
- For already separated employees, the firearms qualifications test must be at the expense of the applicant and must meet the current standards for active law enforcement officers to carry a firearm established by the Wisconsin Law Enforcement Standards Board.

Renewal of Certification Cards:

Requests for renewal of the certification card SHOULD be made prior to the expiration of the certification card, and the applicant must meet the certification requirements.

AN EXPIRED CARD DOES NOT PROVIDE THE FORMER OFFICER THE PRIVILEGE TO CARRY CONCEALED.

NOTED LEGISLATION/STATUTES

HR218, 926B:

- (c) As used in this section, the term "qualified law enforcement officer" means an employee of a governmental agency who—
- 1) is authorized by law to engage in or supervise the prevention, detection, investigation, or prosecution of, or the incarceration of any person for, any violation of law, and has statutory powers of arrest;
 - 2) is authorized by the agency to carry a firearm;
 - 3) is not the subject of any disciplinary action by the agency *which could result in suspension or loss of police powers*;
 - 4) meets standards, if any, established by the agency which require the employee to regularly qualify in the use of a firearm;
 - 5) is not under the influence of alcohol or another intoxicating or hallucinatory drug or substance; and
 - 6) is not prohibited by Federal law from receiving a firearm.

175.49(2)(b)

(b) The law enforcement agency may not issue the former law enforcement officer a certification card under par. (a) unless the law enforcement agency first verifies all of the following:

1. The former law enforcement officer separated from service as a law enforcement officer with the law enforcement agency that employed him or her in good standing.
2. The former law enforcement officer served as a law enforcement officer for an aggregate of at least 10 years or the former law enforcement officer separated from law enforcement service due to a service-connected disability, as determined by the law enforcement agency from which he or she separated from service, after completing any applicable probationary period.
3. Both of the following:
 - a. A qualified medical professional employed by the law enforcement agency from which the former law enforcement officer separated from service has not found the former law enforcement officer to be unqualified to be a law enforcement officer for reasons related to the former officer's mental health.
 - b. The former law enforcement officer has not entered into an agreement with the law enforcement agency from which he or she separated from service in which the former officer acknowledges that he or she is not qualified to be a law enforcement officer for reasons related to his or her mental health and in which he or she declines the photographic identification for that reason.
4. The former law enforcement officer is not prohibited under federal law from possessing a firearm as indicated by a search of the transaction information for management of enforcement system and the national criminal background check system.
5. The former law enforcement officer has, during the previous 12 months at his or her own expense, been found by the state, or by a certified firearms instructor if such an instructor is qualified to conduct a firearms qualification test for active law enforcement officers in the state, to meet the standards for qualification in firearms training for active law enforcement officers to carry a firearm of the type under par. (a) 1., that are established by the state or, if the state does not establish standards, by the law enforcement agency from which the former law enforcement officer separated or its successor agency.

175.49(6) IMMUNITY.

(a) When acting in good faith under this section, the department and its employees and a law enforcement agency and its employees are immune from civil and criminal liability arising from any act or omission under this section.

 - c. I will return the issued card to the Sheriff's Office.
