

## WHERE TO APPLY?

- ♥ If you are a Wisconsin resident or a non-resident, you may apply for a marriage license in any Wisconsin county.
- ♥ The Officiant, wedding date and location must be finalized when applying for a marriage license.
- ♥ You may apply 4 days before the wedding date but no earlier than 60 days before (referred to as "Waiting Period").
- ♥ All documents must be presented, and fees paid at the time the marriage application is made.

## MARRIAGE APPLICATION CHECKLIST

\_\_\_\_ State Certified Birth Certificate (Hospital Certificates/State Notification of Birth Registrations are not accepted.) (This applies if the applicant has been issued a birth certificate and is an obtainable document if not in possession.)

\_\_\_\_ Photo ID (i.e. driver's license, permanent resident card, passport, etc.)

\_\_\_\_ Social Security Card (requirement applies only if applicant has been issued a social security number)

\_\_\_\_ Previous Marriage(s) – "Findings of Fact & Conclusions of Law" and final Divorce Judgment (**Judge's signature is required on documents presented**), Death Certificate, or State Annulment.

\_\_\_\_ A Parental Consent Form is required for applicants 16 to 17 years of age. No one under the age of 16 may apply for a marriage license. No waiver of the 3-day waiting period is issued.

## FEES

### **ALL FEES ARE NON-REFUNDABLE**

\_\_\_\_ **\$125 Application Fee** if license is applied for 4 days to 60 days prior to the wedding date. We accept cash, local check, debit card and credit card.

OR

\_\_\_\_ **\$150 (no personal checks)** if the license is applied for less than 4 days prior to the wedding date, an application and waiver fee are collected. We accept cash, debit card and credit card.

**\* Please note that debit cards have a \$2.50 transaction fee and credit card payments have a 6% transaction fee.**

### **Special Medical Circumstances (if Applicable):**

An additional \$125 Transportation fee to an offsite location within Brown County (i.e. hospital, nursing home, etc.) All related fees must be paid in cash or by debit or credit card.

# INFORMATION GUIDE

**Marriageable Age:** Any person who has attained the age of 18 years may marry. If a person is 16 or 17 years old, the license will be issued only with the written consent of parents, guardian, or custodian. No waiver of the 3-day waiting period will be issued. Consent forms are available in the Brown County Clerk's Office.

**Birth Certificate:** Hospital birth certificates and State Notification of Birth are not acceptable documents. An applicant provided State Certified birth certificate must have a raised official seal.

**Social Security Card:** A Social Security Card must be presented to Brown County Clerk's Office staff by the applicant (if a Social Security Card has been issued).

**Photo Identification:** **Each applicant is required to provide Photo Identification.**

**In/Out of State Residents:** An application may be completed in any Wisconsin county by both in-state or out of state residents.

**Previous Marriage(s):** Applicants must present a Death Certificate, State Annulment, or *Finding of Facts and Conclusions of Law* of the Final Divorce Judgement from their most recent marriage. **Final divorce judgments require a judge's signature and date.** Divorced person(s) may not remarry until 6 months after the granting of the Judgment of Divorce regardless of where the action took place.

**License Application & Expiration:** The license is valid for 60 days from the issue date. The marriage must take place within this period of time. If not, a new license must be obtained, and fees are collected again.

**Waiting Period:** Apply a minimum of four (4) days prior to the day of the wedding. The license becomes effective on the 4<sup>th</sup> day following both parties signing the application. Waiver of the 3-day waiting period may be granted; however, a \$25 waiver fee shall be charged. *(Waiting period does not include the day the marriage application is signed and the day of the wedding).*

**Ceremony Officials:** Couples shall make their own wedding arrangements. An accredited ordained minister, priest, judge, or other person qualified to be an "Officiant" may perform the ceremony *(per WI. State stat. § 765.16).*

Officiants must be 18 years of age or older.

**Neither the Wisconsin Vital Records Office nor does the Brown County Clerk's Office provide confirmation of the legality of a religious officiant.**

Should you question the legality of the officiant of which you have chosen, you may want to seek legal counsel.

**Marrying Parties:** Both applicants must sign the marriage license application in the presence of the County Clerk's staff.

## ALL FEES ARE NON-REFUNDABLE

**Fees:** The license application fee is **\$125** (cash, local check, debit or credit cards). However, a \$25 waiver fee is charged, if the marriage license needs to be issued a date earlier than the 3-day waiting period. Then, the total amount collected is **\$150 – Cash, Debit, or Credit Card Only – NO PERSONAL LOCAL CHECKS ARE ACCEPTED FOR THE WAIVER FEE**

If the marriage application must be transported to a healthcare off-site location to obtain a signature, the transportation fee is \$125 and all related fees must be paid in cash, or by debit or credit card. *Please note that fees are non-refundable.*

**Certified Documents from the Register of Deeds:** Birth Certificates, Death Certificates and Marriage Certificates may be obtained from the Register of Deeds.
