Goals of the Incident Command COVID-19 Response

- Slow the spread of COVID-19 in Brown County to minimize illness and death.
- Keep Brown County open using proactive prevention efforts.
- Promote both community and internal resiliency efforts.
- Ensure Brown County residents have access to COVID-19 vaccine in a timely and equitable manner.

Successes/Milestones this week

- Announced the opening of the Lambeau Field Community Vaccination Site in partnership with Bellin Health and the Packers.
- Board of Health passed a motion of support for the Community Health Assessment.
- Brown County Health and Human Services-Public Health Division received the United Way Community Impact Award for our work during the COVID-19 pandemic.
- March 11, 2021 was the first day of vaccine clinical operations at NEW Community Clinic.
- Shared a Vaccine Distribution Equity Plan with DHS and Governor Evers. This plan lays out how Brown County Public Health, Bellin Health, and the Packers will ensure there is equitable distribution of the COVID-19 vaccine at the Lambeau Field clinic site.

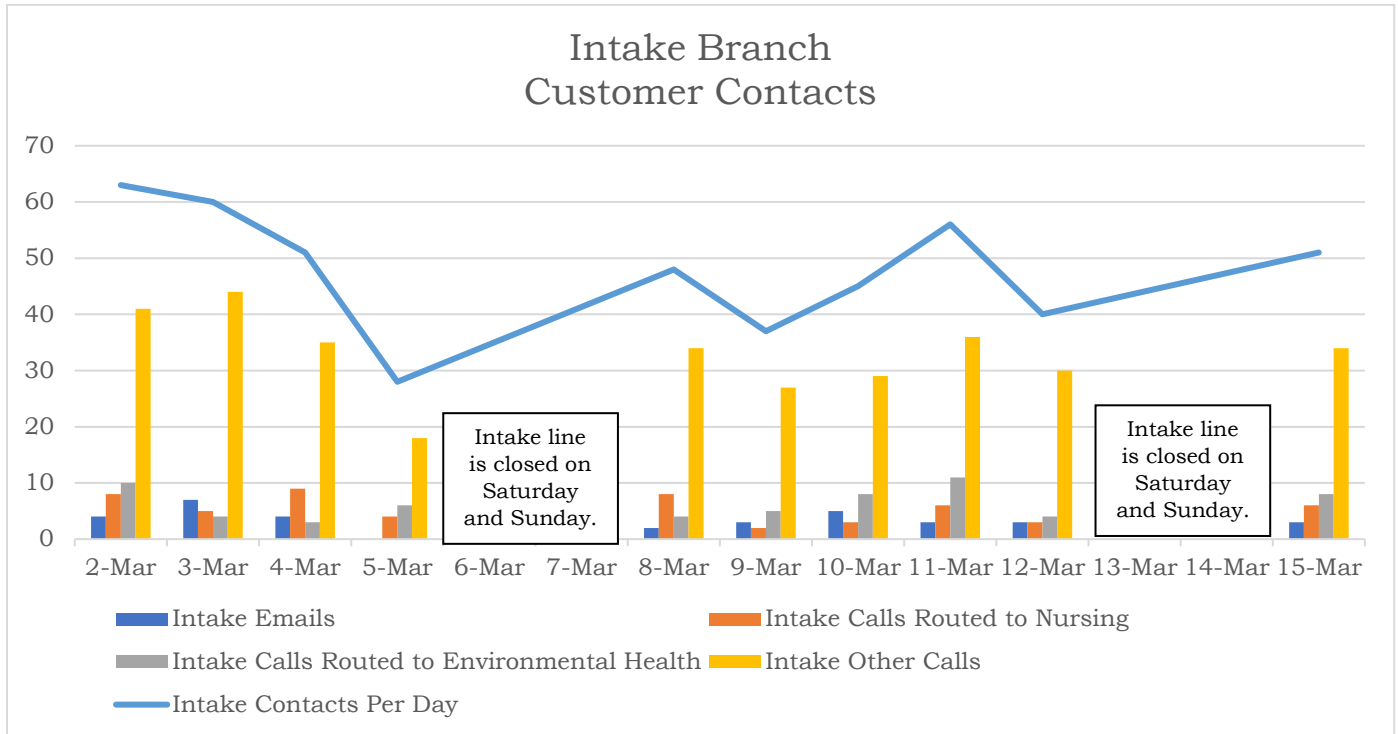

Vaccination Planning: Biweekly Summary	
Consideration	Incident Command (IC) Response
Internal Vaccination Efforts and Processes	<ul style="list-style-type: none"> BCPH worked to create a supplemental survey to help identify early childhood, daycare, and other childcare facilities. The information from the second survey will serve as a data point so updates can be made to the DHS survey submitted on 2/26. BCPH continues to work on identifying gaps within the K-12 and early childhood sub populations to provide equitable access. BCPH began developing a document with the status of the current vaccination efforts. The document will serve as an informative tool outlining current efforts and projections for vaccinating residents of Brown County.
Vaccination Partnerships and Planning	<ul style="list-style-type: none"> BCPH and Bellin’s planning and logistics team collaborated to develop a clinic flow and process document. The document will serve as a resource at mass clinic sites explaining process flow and aiding patients in understanding steps in the vaccination process. The document will be provided in English, Spanish, Hmong, and Somali to serve all patients in an equitable manner. BCPH utilized the DHS provided K-12 vaccination allocation tool to request vaccine for educators who were identified in the current eligible population as a priority. Brown County area school districts and area early childhood organizations were provided a survey to request vaccine for all their employees. All district requests for vaccinators were honored and all remaining educators were provided scheduling instructions with one of the three area healthcare providers. BCPH met with representatives from Walgreens Pharmacy to discuss the possibility of a future partnership. Stand-alone on-site clinics, scheduling processes currently in place, and a collaborative approach to equitable vaccine distribution were the main areas of discussion. Research is ongoing into the pharmacy capacity to vaccinate within our county as the Pharmacy Partnership Program begins to slow down.
