Nidaamyadani ma dafirayaan xaqa uu u leeyahay cabashada in uu dacwooyin rasmi ah u gudbiyo hay'adaha kale ee dawlad-goboleedka ama federaalka ama u raadsado lataliye gaar ah cabashooyinka ku saabsan takoorka.

Habka cabashada xuquuqda madaniga ah waxa kale oo isticmaali kara GUDDIGA QORSHEEYNTA DEGMADA BROWN/GREEN BAY MPO si wax looga qabto, loo xalliyo, oo loo xiro cabashooyinka guud.

Dadaal kasta ayaa la samayn doonaa si loo helo xalinta cabashooyinka goor hore oo ah heerka ugu hooseeya ee suurtogalka ah. Ikhtiyaarka shirarka dhexdhexaadinta aan rasmiga ahayn ee u dhexeeya dhinacyada ay khusayso iyo GUDDIGA QORSHEEYNTA GUDDIGA GREEN BAY MPO Ciwaanka VI ee BROWN ayaa laga yaabaa in loo isticmaalo xalinta, marxalad kasta oo habka. GUDDIGA QORSHEEYNTA GUDDIGA QORSHEEYNTA EE GREEN BAY MPO Iskuduwaha Ciwaanka VI wuxuu samayn doonaa dadaal kasta si uu u sii wado xalinta cabashada.

Cabashooyinka waxaa loo gudbin karaa GUDDIGA QORSHEEYNTA EE DEGMADA BROWN/GREEN BAY MPO qoraal ahaan email ahaan ama telefoon ahaan. Cabashooyinka waxaa lagu dhiirigelinayaa inay buuxiyaan Foomka Cabashada. Cabashooyinka lagu helo taleefoonka waxaa loo dhimi doonaa qoraal waxaana la siin doonaa cabashada si loo xaqiijiyo ama dib u eegis loogu sameeyo ka hor inta aan la xalin.

Cabashooyinka waa inay ku jiraan macluumaadka soo socda:

- ✓ Macluumaadka xiriirka cabashada, oo ay ku jiraan, haddii la heli karo: magac buuxa, cinwaanka boostada, lambarka taleefanka, iyo cinwaanka iimaylka.
- ✓ Saldhigga cabashada (tusaale, isir, midab, asal qaran, naafo, iwm.).
- ✓ Taariikhaha fal-takoorka lagu eedeeyay iyo in takoorka lagu eedeeyay uu socdo.
- ✓ Magacyada dad gaar ah ama jawaab-bixiyeyaal (tusaale, wakaaladaha/ururada) ee lagu eedeeyay in ay takooreen.
- ✓ Macluumaad ku filan oo lagu fahmo xaqiiqooyinka u horseeday cabashadaha in uu rumaysto in takoorku ka dhacay barnaamij ama hawl hela kaalmada maaliyadeed ee dawladda dhexe.

Dacwooyinka la helo waa la aqoonsan doonaa oo laga baaraandegi doonaa, marka la dhiso u jeedada Cabashada ee ah in la sii wado cabashada.

Baaritaanka Cabashooyinka

Dacwooyinka uu komishanka qorsheynta ee BROWN COUNTY/GREEN BAY MPO lagu magacaabay jawaab-celiye (ie, qaataha/wakhtiga cabashada takoorka la gudbiyay) waa in loo gudbiyaa hay'adda ku habboon ee Gobolka ama Federaalka si ay u meel mariso, si waafaqsan habraacyada.

GUDDIGA QORSHEEYNTA EE DEGMADA BROWN/GREEN BAY MPO ayaa qaadi doona mas'uuliyadda baarista cabashooyinka ka dhanka ah qandaraaslayaasheeda, la taliyayaasheeda, kireystayaal, iwm.

Si loo aqbalo, cabashada xuquuqda madaniga ah waa inay buuxisaa shuruudaha soo socda:

1. Cabashada waa in lagu xereeyaa 180 maalmood gudahooda laga bilaabo dhacdada lagu eedeeyay ama marka takoorka lagu eedeeyay uu ogaaday cabashada.
2. Eedaymaha(yaasha) waa in ay ka hadlaan ilaalinta takoor la'aan sida isir, midab, asal qaran, naafo, iwm.
3. Eedaymaha(yaasha) waa in ay ku lug yeeshaan barnaamij ama hawl qaate-caawin federaali ah, qandaraasle, lataliye, ama kireeyste.

GUDDIGA QORSHEEYNTA GUUD EE GREEN BAY MPO dib u eegis iyo go'aaminta talaabada ku haboon ee ku saabsan cabasho kasta.

Marka cabashada la helo, GUDDIGA QORSHEEYNTA BROWN COUNTY/GREEN BAY MPO waxay ku siin doontaa qirasho qoraal ah cabashada 30 maalmood oo shaqo gudahood. Cabashada waala ogeysiyo

tallaabada la soo jeediyay in la qaado si loo habeeyo eedeymaha. Warqadda ogeysiinta/emaylka waa in ay ka koobnaataa:

- ✓ Saldhigga cabashada.
- ✓ Qoraal kooban oo ku saabsan eedaymaha (yaasha) ay awood u leeyihiin GUDDIGA QORSHEEYNTA GOBOLKA BROWN/GREEN BAY MPO.
- ✓ Tilmaanta marka dhinacyada lala xidhiidhi doono.

Baaritaanka uu sameeyay GUDDIGA QORSHEEYNTA EE DEGMADA BROWN/GREEN BAY MPO waxa uu ka kooban yahay wareysi shaqsi ah oo lala yeeshay Cabashooyinka. Macluumaadka lagu soo ururiyey waraysigan waxa ku jira laakiin aan ku xaddidnayn macluumaadka lagu buuxiyey Foomka Dacwadda.

Haddii loo baahdo macluumaad dheeraad ah si wax looga qabto cabashada, GUDDIGA QORSHEEYNTA DEGMADA BROWN/GREEN BAY MPO waxa laga yaabaa inay la xidhiidho cabashada. Haddii cabashada loo arko mid aan dhammaystirnayn ama haddii macluumaad dheeraad ah la codsado, cabashada waxa la siin doonaa 30 maalmood oo shaqo si uu u gudbiyo macluumaadka loo baahan yahay. Ku guuldareysiga in sidaas la sameeyo waxaa loo tixgelin karaa sabab wanaagsan oo lagu go'aamin karo wax faa'iido baaris ah.

60 maalmood oo shaqo gudahooda laga bilaabo aqbalida cabashada, GUDDIGA QORSHEEYNTA DEGMADA BROWN/GREEN BAY MPO ayaa diyaarin doona warbixin baaritaan. Warbixintu waa inay ku jirtaa sharraxaad ka-sheekayn dhacdada, aqoonsiga dadka la waraystay, natiijooyinka, iyo talo-soo-jeedinta. Kaliya baarayaal si macquul ah u qalma oo tababaran waa inay sameeyaan baaritaanka.

Kadib komishanka Qorshaynta Degmada BROWN/GREEN BAY MPO dib u eegeen cabashada, mid ka mid ah laba (2) waraaqo waxaana loo soo saari doonaa cabashada: warqad xidhidh ama warqad raadin (LOF).

- ✓ Warqad xiritaan ah ayaa soo koobeysa eedeymaha waxaana lagu sheegay in aysan jirin ku xad-gudub xuquuqda madaniga ah iyo in kiiska la xirayo.
- ✓ Warqadda baadhista (LOF) waxay soo koobaysaa eedaymaha iyo waraysiyada ku saabsan dhacdada lagu eedeeyay, waxayna sharraxaysaa haddii tallaabo anshaxeed, tababar dheeraad ah oo xubin shaqaale ah, ama tallaabo kale dhici doonto.

Haddii dacwooduhu uu rabo inuu rafcaan ka qaato go'aanka, dacwad-qaaduhu wuxuu haystaa 30 maalmood oo shaqo kadib taariikhda warqadda lagu ogaaday inuu sidaas sameeyo.

Xil ka qaadis

3. Dacwad-oogaha lama heli karo isku dayo macquul ah ka dib.
